## GENERAL TERMS AND CONDITIONS

- 1. Application.** Please complete the application form and send it to Admissions at Uceda Worldwide with the non-refundable application fee. We recommend early application since classes fill well in advance.
- 2. Housing.** Availability varies depending on the time of year. Requests will be honored where possible. Requests for Uceda Worldwide to assist you in finding accommodations must be made thirty (30) days prior to your arrival. Students may make their own housing arrangements if they desire.
- 3. Cancellation.** "Cancellation" refers to those cancellations made before you leave your own country. If cancelled four (4) or more weeks before the course start date, all tuition will be refunded. Uceda Worldwide will retain the application and health insurance fees. If cancelled less than four (4) weeks before the course start date, the cost of housing for the first four (4) weeks of the program will be deducted from the refund to cover the cost of prepaid housing.
- 4. Termination.** "Termination" means leaving the course once you have registered for classes and the course has begun. You have the right to cancel anytime. Upon termination, Uceda Worldwide offers refunds according to the following schedule:

Day 1	100% of tuition
Day 2	85% of tuition
Day 3	55% of tuition
Day 4	40% of tuition
Day 5	25% of tuition

No refund is offered after the fifth day of class for any reason.
- 5. Refunds.** No refunds are given for the following fees: application, housing, airport pick-up/drop-off, and express mail fee. An exception will be made for airport transport if the student notifies Uceda Worldwide at least 24 hours prior to the scheduled pick-up time.
- 6. Schedule.** All credit hours are fifty (50) minutes in duration.
- 7. Substitution Policy.** If a student, after taking a placement test, is found to be at a level lower than the minimum start level for the course, the school reserves the right to place the student in a more appropriate class. We also reserve the right to cancel courses at any time due to insufficient demand. In such cases, students will be transferred to a course of equivalent duration with no right to financial compensation.
- 8. Rules and Regulations.** Uceda Worldwide students are subject to the laws, rules and regulations of the country, state, county, city, and school they attend.
- 9. Course Certificates.** Students who meet course requirements and are in good standing receive a certificate or diploma.
- 10. Holidays.** Classes are normally not held and school facilities are closed on national holidays. You will receive information on these holidays in your student packet or handbook. Compensation will not be made for public holidays.
- 11. Failure to Appear.** Your course will be cancelled without refund if you fail to arrive within four (4) days of your program's start date. No refund will be granted if you fail to attend classes once your program has begun and no notice has been given.
- 12. Attendance.** Attendance is an integral part of your course and an important staple of the learning process. Neither refunds, nor class time will be given for classes not attended.
- 13. Prices.** Uceda Worldwide reserves the right to change prices at any time or for any reason.
- 14. Program Changes.** Uceda Worldwide reserves the right to change starting dates, course curriculum, and programs at any time.
- 15. Terms and Conditions.** These terms and conditions supersede all previous publications and are valid until such time that Uceda Worldwide issues new terms and conditions.
- 16. Force Majeure.** It is a basic stipulation of the agreement/contract between students and Uceda Worldwide or representatives, that neither Uceda Worldwide, nor any of its representatives, is liable to the students in cases where Uceda Worldwide is unable to fulfill any services to which they are contractually bound because of labor disputes or other reasons beyond their control.
